The CVWMA has been busy making a positive impact in all of the communities in our region! The Board and Staff have worked collaboratively with our member jurisdictions on developing a strategic plan that will serve as a roadmap to further collaboration that will result in social, economic, and environmental advances in the region. CVWMA continues to be a leader in the Commonwealth of Virginia with the highest regional recycling rate reported by the VA DEQ of 58.8%. Over 500,000 tons of waste was recycled and diverted from local landfills in 2015. In July 2015, the City of Richmond enhanced its recycling program by going to 95 gallon recycling carts citywide, which has led to a 50% increase in waste diversion, collection efficiencies, and overall reduction in its carbon footprint. In addition, the CVWMA operates under a balanced budget while providing cost effective programs to member localities and even provides revenue back to member jurisdictions from the sale of recyclable materials. We are proud of all that CVWMA has achieved and we look forward to taking advantage of opportunities that will further our mission and vision.

eWaste Collection events held in all CVWMA localities FY2016 successfully collected **540,519 lbs**.




Debris Management
